

Hearing for the Re-Adoption of the 2015 Budget
Northeast Indiana Solid Waste Management District Budget
October 14, 2014

Steuben County Council met on Tuesday, October 14, 2014 at 9:00 AM at the Steuben Community Center Building, Suite 2H, 317 S Wayne Street, Angola Indiana, to re-adopt the 2015 Northeast Indiana Solid Waste Management District Budget Form # 4, Resolution for Appropriations and Tax Rate.

Present were Richard Shipe, Ruth Beer, Dan Caruso, Wil Howard and Ken Shelton. Also present was Kim Koomler, Council Secretary and County Auditor. Linda Hansen and F. Mayo Sanders were both absent.

Richard Shipe called the hearing to order. Shipe explained that in the Notice to Taxpayers for Northeast Indiana Solid Waste Management District, the budget was to have been adopted on Tuesday September 16, 2014 however, the Steuben County Council adopted the Northeast Indiana Solid Waste Management District Budget Resolution # 09-2014-02 on Tuesday, September 9, 2014 in error. Shipe told Council members that they will need to rescind the Resolution # 09-2014-02 due to this clerical error. Ruth Beer made the motion to rescind Resolution # 09-2014-02. Dan Caruso seconded and the motion carried with a vote of five (5) ayes and zero (0) nays.

The following notice was published in two local newspapers, The Hamilton News and The Herald Republican on Tuesday October 7, 2014 as per Department of Local Government Finance requirements. Notice must be published one time in two newspapers at least 48 hours prior to the date of the re-adoption hearing. The notice must be clearly posted in three locations including the Solid Waste District office. The notice was posted at the Northeast Indiana Solid Waste Management District Office located at 2320 W 800 S, Ashley, IN, 46706 and the Steuben Community Center Building, 317 S Wayne Street, Suite 2H, Commissioners Meeting Room Notification Board and at the Steuben County Courthouse located on the Public Square, Angola Indiana, 46703.

Be it resolved by the Steuben County Council that the expenses of Northeast Indiana Solid Waste Management District for the year ending December 31, 2015 the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided for by law. In addition for the purposes of raising revenue to meet the necessary expenses of Northeast Indiana Solid Waste Management District, the property tax levies and property tax rates as herein specified are included herein. Budget Form 4-B for all funds must be completed and submitted in the manner prescribed by the Department of Local Government Finance.
